Today a total of 716 B shares (KESKOB) have been returned to Kesko Corporation without consideration in accordance with the terms and conditions of Kesko's share-based commitment and incentive plan PSP 2019-2022. The shares had initially been granted to a person included in the target group of the 2019-2020 performance period of the plan.

Following the return of the shares, Kesko holds 2,969,380 of its own B shares as treasury shares.
