# Kesko Sweden to concentrate its building and home improvement trade operations under the K-Bygg chain

Kesko will concentrate its building and home improvement trade operations in Sweden under the K-Bygg chain, and will increasingly focus on serving building professionals alongside consumers. The K-Rauta stores in Sweden will either be converted into K-Bygg stores or closed. Kesko's building and home improvement trade operations in Sweden will be concentrated under one brand by the end of 2024.

Kesko is a leading operator in building and technical trade in Northern Europe and has a solid foothold and long history in Sweden. At the moment, Kesko operates in Sweden under two building and home improvement trade chains, K-Bygg and K-Rauta, as well as in technical wholesale.

In the future, Kesko's business in the Swedish building and home improvement market will focus on serving B2B and B2C customers in K-Bygg stores. K-Bygg is a successful nationwide chain that currently has 51 stores across the country. The current 16 K-Rauta stores in Sweden will be either converted into K-Bygg stores or closed.

Kesko's technical wholesale operations will continue as before under the Onninen brand.

"Kesko has a growth strategy that focuses on Northern Europe. In Sweden, we want to grow the K-Bygg chain both organically and through acquisitions. Focusing more strongly on and investing in the building and home improvement market for professionals is a strategic choice that builds future success and growth by improving our efficiency and profitability", says **Jorma Rauhala**, President of Kesko's building and technical trade division.

The concentration of building and home improvement operations in Sweden under the K-Bygg brand will be completed by the end of 2024.
